The Income Support (General) (Standard Interest Rate Amendment No. 3) Regulations (Northern Ireland) 2001

The Department for Social Development, in exercise of the powers conferred by sections 122(1)(a), 131(1) and 171(1) and (3) to (5) of the Social Security Contributions and Benefits (Northern Ireland) Act $1992(\mathbf{a})$, and now vested in it(**b**), and of all other powers enabling it in that behalf, hereby makes the following Regulations:

Citation, commencement and interpretation

1.—(1) These Regulations may be cited as the Income Support (General) (Standard Interest Rate Amendment No. 3) Regulations (Northern Ireland) 2001 and shall come into operation on 16th December 2001.

(2) These Regulations shall have effect in relation to any particular claimant—

- (a) in a case where income support is paid to the claimant in arrears in accordance with paragraph (1)(a) of Schedule 2A to the Decisions and Appeals Regulations(c) (date when change of circumstances is to take effect in certain cases where a claimant is in receipt of income support or a jobseeker's allowance)—
 - (i) from the first day of the benefit week which includes 23rd December 2001, or
 - (ii) if the claim for income support is for a period commencing after 23rd December 2001, from the first day of the first benefit week commencing after 16th December 2001;
- (*b*) in a case where income support is paid to the claimant in advance in accordance with paragraph (1)(*b*) of Schedule 2A to the Decisions and Appeals Regulations, from the first day of the first benefit week commencing after 23rd December 2001,

and for this purpose, the expressions "claimant" and "benefit week" have the same meanings as in regulation 2(1) of the Income Support Regulations(**d**) (interpretation).

(3) In these Regulations—

- "the Decisions and Appeals Regulations" means the Social Security and Child Support (Decisions and Appeals) Regulations (Northern Ireland) 1999(**a**);
- "the Income Support Regulations" means the Income Support (General) Regulations (Northern Ireland) 1987(b).

(4) The Interpretation Act (Northern Ireland) 1954(c) shall apply to these Regulations as it applies to an Act of the Assembly.

Amendment of Schedule 3 to the Income Support Regulations

2. In Schedule 3 to the Income Support Regulations(d) (housing costs), in paragraph 12(1)(a) (standard rate of interest on qualifying loans) for "6.65 per cent." there shall be substituted "6.19 per cent.".

Revocation

3. The Income Support (General) (Standard Interest Rate Amendment No. 2) Regulations (Northern Ireland) 2001(e) are hereby revoked save that those Regulations shall continue to have effect until the day before the first day of the benefit week having effect in relation to any particular claimant for the purpose of regulation 1(2) of these Regulations.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations amend Schedule 3 to the Income Support (General) Regulations (Northern Ireland) 1987 with respect to the standard rate of interest applicable to a loan which qualifies for income support. The rate is decreased from 6.65 per cent. to 6.19 per cent. (regulation 2). The Regulations also revoke, with a saving provision, the Income Support (General) (Standard Interest Rate Amendment No. 2) Regulations (Northern Ireland) 2001 which made a previous amendment to the standard rate of interest (regulation 3).

These Regulations make in relation to Northern Ireland only provision corresponding to provision contained in Regulations made by the Secretary of State for Work and Pensions in relation to Great Britain and accordingly, by virtue of section 149(3) of, and paragraph 10 of Schedule 5 to, the Social Security Administration (Northern Ireland) Act 1992 (c. 8), are not subject to the requirement of section 149(2) of that Act for prior reference to the Social Security Advisory Committee.

These Regulations do not impose a charge on business.
