**The Education (Student Support) (Amendment) Regulations
(Northern Ireland) 2003**

Made - - - - - *16th July 2003*

Coming into operation *11th August 2003*

The Department for Employment and Learning^(a), in exercise of the powers conferred by Articles 3 and 8(4) of the Education (Student Support) (Northern Ireland) Order 1998^(b) and now vested in it^(c) and of every other power enabling it in that behalf, hereby makes the following Regulations: –

Citation and commencement

1. These Regulations may be cited as the Education (Student Support) (Amendment) Regulations (Northern Ireland) 2003 and shall come into operation on 11th August 2003.

Amendments

2.—(1) Regulation 20 of the Education (Student Support) Regulations (Northern Ireland) 2003 shall be amended as provided by paragraphs (2) and (3).

(2) At the beginning of paragraph (14) there shall be inserted “Subject to paragraph (14A),”.

(3) After paragraph (14) there shall be inserted the following paragraph:

“(14A) Where the maximum amounts of loan set out in paragraphs (1) and (2) are reduced under paragraph (14), such reduction shall not have effect so as to reduce the amount of loan below the amount applicable to the student under regulation 24(6) or (7).”.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations amend the Education (Student Support) Regulations (Northern Ireland) 2003 (“the principal regulations”).

The amendment to regulation 20 corrects a drafting error in the principal regulations to ensure that students in receipt of bursary under regulation 13, whose loan entitlement is reduced under regulation 20 (14) to an amount less than the amount applicable to them under regulation 24(6) or (7), are entitled to the higher amount.
