**The Education (1998 Order) (Commencement No. 5) Order  
(Northern Ireland) 2005**

*Made* - - - - - *29th April 2005*

The Department of Education, in exercise of the powers conferred on it by Article 1(3) of the Education (Northern Ireland) Order 1998<sup>(a)</sup>, and of all other powers enabling it in that behalf, hereby makes the following Order:

**Citation**

**1.** This Order may be cited as the Education (1998 Order) (Commencement No. 5) Order (Northern Ireland) 2005.

**Appointed Day**

**2.** The following provisions of the Education (Northern Ireland) Order 1998 shall come into operation on 29th April 2005, that is to say –

- (a) Articles 55 to 60;
- (b) Articles 67 and 68; and
- (c) Articles 70 to 72.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order brings into operation the following Articles of the Education (Northern Ireland) Order 1998, Part VII, Financing of Schools:

- Articles 55 to 57 provide for the suspension, review, and appeal procedures relating to the withdrawal of financial delegation;
- Article 58 which makes provisions relating to the staff of controlled and maintained schools with delegated budgets;
- Articles 59 and 60 provides for the financing by boards of special schools, and Article 67 provides for the preparation of financial statements for special schools managed by the board;
- Article 68 provides for building and equipment grants for voluntary schools; and
- Articles 70 to 72 provide for miscellaneous financial provisions relating to schools.
