The Pharmaceutical Society of Northern Ireland (General) (Amendment) Regulations (Northern Ireland) 2006

Made - - - - 8th May 2006

Coming into operation 1st June 2006

The Council of the Pharmaceutical Society of Northern Ireland, in exercise of the powers conferred by Article 5 of the Pharmacy (Northern Ireland) Order 1976(a) makes the following Regulations with the approval of the Department of Health, Social Services and Public Safety(b).

Citation and commencement

- 1.—(1) These Regulations may be cited as the Pharmaceutical Society of Northern Ireland (General) (Amendment) Regulations (Northern Ireland) 2006 and shall come into operation on 1st June 2006.
- (2) In these Regulations "the principal regulations" means the Pharmaceutical Society of Northern Ireland (General) Regulations (Northern Ireland) 1994(c).

Amendment of the principal regulations

- **2.** In regulation 3 of the principal regulations (restoration fees) for "£87" there shall be substituted "£104".
 - 3. In regulation 4 of the principal regulations (retention fees)—
 - (a) in paragraph (1)(a) for "£245" there shall be substituted "£295";
 - (b) in paragraph (2)(a) for "£113" there shall be substituted "£135";
 - (c) in paragraph (2)(b) for "£90" there shall be substituted "£108";
 - (d) in paragraph (2)(c) for "£41" there shall be substituted "£49".
