**Rates (Amendment) (2006 Order) (Commencement  
No. 1) Order (Northern Ireland) 2006**

2006

The Department of Finance and Personnel<sup>(1)</sup> makes the following Order in exercise of the powers conferred by Article 1(3) of the Rates (Amendment) Northern Ireland) Order 2006<sup>(2)</sup>:

**Citation and interpretation**

1.—(1) This Order may be cited as the Rates (Amendment) (2006 Order) (Commencement No. 1) Order (Northern Ireland) 2006.

(2) In this Order “the 2006 Order” means the Rates (Amendment) (Northern Ireland) Order 2006.

**Appointed days**

2.—(1) 23rd November 2006 is the day appointed for the coming into operation of the provisions of the 2006 Order listed in column (1) of Schedule 1 for the purposes set out in column (3) thereof.

(2) 1st December 2006 is the day appointed for the coming into operation of the provisions of the 2006 Order listed in column (1) of Schedule 2 for the purposes set out in column (3) thereof.

(3) 1st January 2007 is the day appointed for the coming into operation of the provisions of the 2006 Order listed in column (1) of Schedule 3 for the purposes set out in column (3) thereof.

(4) Except for Article 4, the day appointed for the coming into operation of the provisions of the 2006 Order, in so far as they have not been brought into operation before 1st April 2007, is 1st April 2007.
