**PART III**

**MISCELLANEOUS**

**Enforcement, offences and proceedings**

**22.** The following provisions of the 1981 Order shall apply as if these Regulations were an order made under the 1981 Order—

- (a) Article 6 (seizure and destruction of carcasses, etc., liable to spread disease);
- (b) Article 42 (functions of constables);
- (c) Article 46 (general powers of inspectors);
- (d) Article 46A (powers of inspectors relating to [F1retained EU law or Protocol] obligations);
- (e) Article 48 (power to detain vessels and aircraft);
- (f) Article 52 (offences);
- (g) Article 54 (defences and evidence);
- (h) Article 55 (extension of time for bringing summary proceedings);
- (i) Article 56 (venue); and
- (j) Article 57 (proceedings under Customs Acts for unlawful landing or shipping).
