**The Social Security (Netherlands)
Order (Northern Ireland) 2007**

Citation and commencement

1. This Order may be cited as the Social Security (Netherlands) Order (Northern Ireland) 2007 and shall come into operation on 1st June 2007.

Modification of Acts and the Jobseekers (Northern Ireland) Order

2. The Social Security Administration (Northern Ireland) Act 1992, the Social Security Contributions and Benefits (Northern Ireland) Act 1992(1) and the Jobseekers (Northern Ireland) Order 1995(2) are modified to such extent as may be required to give effect to the provisions contained in the Convention set out in the Schedule so far as they relate to Northern Ireland.

3.—(1) The National Insurance and Industrial Injuries (Reciprocal Agreement with the Netherlands) Order (Northern Ireland) 1955(3) is revoked.
