**The Pensions (2008 Act) (Actuarial Guidance)  
(Consequential Provisions) Order (Northern Ireland) 2008**

*Made* - - - - *3rd September 2008*  
*Coming into operation* *1st October 2008*

The Department for Social Development makes the following Order in exercise of the powers conferred by section 19(1) of the Pensions Act (Northern Ireland) 2008(1).

**Citation and commencement**

1. This Order may be cited as the Pensions (2008 Act) (Actuarial Guidance) (Consequential Provisions) Order (Northern Ireland) 2008 and shall come into operation on 1st October 2008.

Article 2

### Amendment of Regulations
