**Pig Production Development (Levy) Revocation (No 2) Order
(Northern Ireland) 2008**

Made - - - - - *5th March 2008*

Coming into operation - *1st April 2008*

The Department of Agriculture and Rural Development (**a**) makes the following Order upon the dissolution of the Pig Production Development Committee (**b**) and in exercise of the powers conferred by section 5(1), (2) and (3) of the Pig Production Development Act (Northern Ireland) 1964 (**c**):

Citation and commencement

1. This Order may be cited as the Pig Production Development (Levy) Revocation (No 2) Order (Northern Ireland) 2008 and shall come into operation on 1st April 2008.

Revocations

2. The following Orders are revoked:

- (a) the Pig Production Development (Levy) Order (Northern Ireland) 1996 (**d**); and
- (b) the Pig Production Development (Levy) Revocation Order (Northern Ireland) 2008 (**e**).
