# Local Government Pension Scheme (Benefits, Membership and Contributions) Regulations (Northern Ireland) 2009

## Final pay: fluctuating emoluments

- 11.— $I^{FI}(1)$  Subject to paragraph (2), where a member's pensionable pay for the purposes of regulation 8(1) (final pay: general) consists of or includes fluctuating emoluments  $I^{F2}$  on which the appropriate contribution rate has been paid], his final pay is calculated as the sum of—
  - (a) the average of all such fluctuating emoluments [F3 on which the appropriate contribution rate has been paid] for the 3 consecutive years ending with the final pay period; and
  - (b) any sums [F40n which the appropriate contribution rate has been paid] falling within regulation 4(1) (meaning of "pensionable pay"), other than fluctuating emoluments, for the final pay period.
- (2) But a member's employer may consent to him having his final pay calculated as the average of all such fluctuating emoluments [F5 on which the appropriate contribution rate has been paid] for any 3 consecutive years ending 31st March within the period of 10 years ending with the last day he was an active member.
