

## **EXPLANATORY MEMORANDUM TO**

### **The Oil and Fibre Plant Seeds Regulations (Northern Ireland) 2009**

**SR 2009 No. 386**

#### **1. Introduction**

- 1.1. This Explanatory Memorandum has been prepared by the Department of Agriculture and Rural Development to accompany the Statutory Rule (details above) which is laid before the Northern Ireland Assembly.
- 1.2. The Statutory Rule is made under powers conferred on it by section 1(1) and (2A) and 2 of the Seeds Act (Northern Ireland) 1965 and is subject to the negative resolution procedure.
- 1.3. The rule is due to come into operation on 30<sup>th</sup> November 2009.

#### **2. Purpose**

- 2.1. The rule consolidates the Oil and Fibre Plant Seeds Regulations and amendments and transposes two EC Directives. EC 2008/62, Conservation Varieties Directive by providing for certain derogations for acceptance of agricultural landraces and varieties which are naturally adapted to the local and regional conditions and threatened by genetic erosion and for marketing of seed and seed potatoes of those landraces and varieties. It also transposes Commission Directive 2009/74/EC as regards the botanical names of plants, the scientific names of other organisms and certain annexes to 66/401/EEC, 66/402/EEC and 2002/57/EC in the light of developments of scientific and technical knowledge.

#### **3. Background**

- 3.1. The principal regulations, Oil and Fibre Plant Seeds Regulations (NI) 1994 has been amended on numerous occasions. The Department now intends to consolidate these (and the other seeds regulations) in the interests of transparency and accessibility.

#### **4. Matters of Special Interest to the Agriculture and Rural Development Committee**

- 4.1. There is no impact on the rural community as this is a consolidation exercise and has no change on the regulatory regime. The Conservation Variety Directive does not have any practical application in Northern Ireland.

#### **5. Consultation**

- 5.1. As required by the Seeds Act 1965, the Department has consulted representatives of the seeds trade and others. No comments were received.

#### **6. Position in Great Britain and Ireland**

- 6.1. All UK and RoI authorities are transposing the Conservation Varieties Directive.

## **7. Equality Impact**

- 7.1. The Department has screened out this legislation under the Equality and Human Rights screening procedures.

## **8. Regulatory Impact**

- 8.1. Not necessary for these Regulations as there is no impact on the private and voluntary sectors. This is a consolidation exercise and therefore has no change in the regulatory regime. The Conservation Variety Directive is being implemented and England has already carried out a Regulatory impact assessment. The Conservation Variety does not have any practical application in Northern Ireland.

## **9. Financial Implications**

- 9.1. There is no financial impact on the rural community as this is a consolidation exercise and has no change in the regulatory regime. The Conservation Variety Directive does not have any practical application in Northern Ireland.

## **10. Section 24 of the Northern Ireland Act 1998**

- 10.1. These Regulations are compliant with Section 24 of the NI Act 1998.

## **11. EU Implications**

- 11.1. This is a transposition of EU directive 62/2008 namely “the conservation variety Directive” and also EU directive 2009/74 namely “the nomenclature directive”.

**Title of policy / decision to be screened:-** Consolidation of the Seeds Regulations.

**Brief description of policy / decision to be screened:-** This is a routine update of the Seeds Regulations to transpose an EU Directive and consolidate previous amendments.

Directive 2008/62/EC, the Conservation Variety Directive amends the Seeds Directives by providing for acceptance of agricultural landraces and varieties, which are naturally adapted to the local and regional conditions and threatened by genetic erosion and for marketing of seed of those landraces and varieties. The proposed Seeds Regulations implement these changes in local legislation as well as consolidating all of the seeds marketing regulations and the registration and licensing regulations.

**Aims and objectives of the policy / decision to be screened:-** To update the Seeds Regulations to transpose an EU Directive and consolidate previous amendments.

**On whom will the policy / decision impact:-** As there is no impact on the private and voluntary sectors, in so far as this is a consolidation exercise it has no impact on the regulatory regime. The Conservation Varieties Directive is being implemented but the provisions of this directive are highly unlikely to have any practical application in Northern Ireland.
