# The Social Security Benefits Uprating Order (Northern Ireland) 2010

## PART 4

### JOBSEEKER'S ALLOWANCE

#### Age-related amounts of contribution-based jobseeker's allowance

**21.** In regulation 79(1) of the Jobseeker's Allowance Regulations(1) (weekly amounts of contribution-based jobseeker's allowance)—

- (a) in sub-paragraph (a) for "£50.95" substitute "£51.85";
- (b) in sub-paragraph (b) for "£50.95" substitute "£51.85"; and
- (c) in sub-paragraph (c) for "£64·30" substitute "£65·45".

#### Applicable amounts for jobseeker's allowance

**22.**—(1) The sums relevant to the calculation of an applicable amount as specified in the Jobseeker's Allowance Regulations(**2**) shall be the sums set out in this Article and Schedules 9 to 12 to this Order; and for this purpose a reference in this Article to a numbered regulation or Schedule is a reference to the regulation of, or Schedule to, the Jobseeker's Allowance Regulations bearing that number.

(2) In—

- (a) regulations 83(b), 84(1)(c) and 85(1); and
- (b) paragraphs 15A(2)(a) and 16(2)(a) of Part III of Schedule 1(3),

the sum specified is in each case £3,000.

(3) The sums specified in Part I of Schedule 1 (applicable amounts: personal allowances) shall be as set out in Schedule 9 to this Order.

(5) The sums specified in Part IV of Schedule 1 (applicable amounts: weekly amounts of premiums) shall be as set out in Schedule 10 to this Order.

(6) The sums specified in Part IVB of Schedule 1(5) (applicable amounts: weekly amounts of premiums for joint-claim couples) shall be as set out in Schedule 11 to this Order.

(7) In paragraph 17 of Schedule 2(6) (housing costs: non-dependant deductions)—

- (a) in sub-paragraph (1) the sums of  $\pounds 47.75$  and  $\pounds 7.40$  remain the same;
- (b) in sub-paragraph (2)(a) the sum of  $\pounds 120.00$  remains the same;
- (c) in sub-paragraph (2)(b) the sums of  $\pounds 120.00$ ,  $\pounds 178.00$  and  $\pounds 17.00$  remain the same;
- (d) in sub-paragraph (2)(c) the sums of £178.00, £231.00 and £23.35 remain the same;
- (e) in sub-paragraph (2)(d) the sums of  $\pounds 231.00$ ,  $\pounds 306.00$  and  $\pounds 38.20$  remain the same; and
- (f) in sub-paragraph (2)(e) the sums of £306.00, £382.00 and £43.50 remain the same.

(8) The sums specified in any provision of the Jobseeker's Allowance Regulations set out in column (1) of Schedule 12 to this Order are the sums set out in column (2) of that Schedule.
