**ROAD TRAFFIC AND VEHICLES**

**The Waiting Restrictions (Downpatrick) Order (Northern  
Ireland) 2010**

*Made* - - - - *12th April 2010*

*Coming into operation* - *4th May 2010*

The Department for Regional Development(a), makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

**Citation and commencement**

1. This Order may be cited as The Waiting Restrictions (Downpatrick) Order (Northern Ireland) 2010 and shall come into operation on 4th May 2010.

**Restriction of waiting**

2. Subject to Article 3 a person shall not cause or permit a vehicle to wait on the lengths of road specified in the Schedule.

**Exceptions**

3.—(1) Nothing in Article 2 shall render it unlawful for a person to cause or permit a vehicle to wait on the carriageway of the lengths of road specified in the Schedule where the person in control of it is prevented from proceeding by circumstances beyond that person's control or to avoid an accident or for so long as necessary to enable—

- (a) a person to board or alight from a vehicle provided that such boarding or alighting does not cause the vehicle to wait in the same place for more than 2 minutes;
- (b) the vehicle to be used for fire and rescue, ambulance, police or customs purposes or for the purposes of the security forces;

- (c) the vehicle to be used for the purposes of delivering or collecting postal packets as defined in section 125 of the Postal Services Act 2000(a);
- (d) the vehicle, if it cannot conveniently be used for such purpose outside that length of road, to be used—
  - (i) in connection with any building, repair or demolition operations;
  - (ii) in connection with the removal of any obstruction to traffic;
  - (iii) by or on behalf of a district council or a government department in pursuance of statutory powers or duties;
  - (iv) by or on behalf of a sewerage undertaker or a water undertaker in connection with the discharge of that undertaker's functions;
  - (v) in connection with the discharge of the functions of the holder of a licence granted under Article 10 of the Electricity (Northern Ireland) Order 1992(b) or of a licence granted under Article 8 of the Gas (Northern Ireland) Order 1996(c); or
  - (vi) in connection with the laying, erection, alteration or repair of any electronic communications apparatus as defined in Schedule 2 to the Telecommunications Act 1984(d);
- (e) goods to be loaded or unloaded from the vehicle.

(2) For the purposes of paragraph (1)(a) a vehicle shall be deemed to wait in the same place for more than 2 minutes if any one part of the carriageway is below any part of the vehicle or its load (if any) throughout the period exceeding 2 minutes whether or not the vehicle is moved during that period.

## SCHEDULE

Articles 2 and 3

### No Waiting at any Time

#### All in Downpatrick

1. St. Patrick's Avenue (north side), from a point 50 metres east of its junction with Folly Lane, for a distance of 94 metres.
2. St. Patrick's Avenue (south side), from a point 23 metres east of its junction with Folly Lane, for a distance of 65 metres.
3. St. Patrick's Avenue (south side), from a point 122 metres east of its junction with Folly Lane, for a distance of 27 metres.

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order prohibits vehicles waiting on the lengths of road specified in the Schedule (Article 2). Vehicles are excepted from the prohibition in certain circumstances (Article 3).

A penalty charge (£60) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be erected on the road.
