# Agriculture (Student fees) (Amendment) Regulations (Northern Ireland) 2010

Made---24th June 2010Coming into operation-1st September 2010

The Department of Agriculture and Rural Development( $\mathbf{a}$ ), in exercise of the powers conferred by sections 5A(1) and (2) of the Agriculture Act (Northern Ireland) 1949( $\mathbf{b}$ ), makes the following Regulations:

#### **Citation and commencement**

**1.** These Regulations may be cited as the Agriculture (Student fees) (Amendment) Regulations (Northern Ireland) 2010 and shall come into operation on the 1 September 2010.

#### Amendment to the Agriculture (Student fees) Regulations (Northern Ireland) 2007

**2.** The Agriculture (Student fees) Regulations (Northern Ireland) 2007(c) shall be amended as provided by regulations 3 and 4.

**3.** In Regulation 4(1)(**d**) for "£1285" substitute "£1310".

4. In Regulation 5(2)(e) for "£640" substitute "£650".

### Revocations

5. The Agriculture (Student fees) (Amendment) Regulations (Northern Ireland) 2009(f) are revoked.
