**Agriculture (Student fees) (Amendment) Regulations (Northern Ireland) 2010**

*Made* - - - - *24th June 2010*

*Coming into operation* - *1st September 2010*

The Department of Agriculture and Rural Development<sup>(a)</sup>, in exercise of the powers conferred by sections 5A(1) and (2) of the Agriculture Act (Northern Ireland) 1949<sup>(b)</sup>, makes the following Regulations:

**Citation and commencement**

1. These Regulations may be cited as the Agriculture (Student fees) (Amendment) Regulations (Northern Ireland) 2010 and shall come into operation on the 1 September 2010.

**Amendment to the Agriculture (Student fees) Regulations (Northern Ireland) 2007**

2. The Agriculture (Student fees) Regulations (Northern Ireland) 2007<sup>(c)</sup> shall be amended as provided by regulations 3 and 4.

3. In Regulation 4(1)<sup>(d)</sup> for “£1285” substitute “£1310”.

4. In Regulation 5(2)<sup>(e)</sup> for “£640” substitute “£650”.

**Revocations**

5. The Agriculture (Student fees) (Amendment) Regulations (Northern Ireland) 2009<sup>(f)</sup> are revoked.
