The Regulation and Quality Improvement Authority (Fees and Frequency of Inspections) (Amendment) Regulations (Northern Ireland) 2010

Made---3rd September 2010Coming into operation29th October 2010

The Department of Health, Social Services and Public Safety makes the following Regulations in exercise of the powers conferred by Articles 13 (2), 16 (3), 17 (3), 40 (7) and 48 (2) of the Health and Personal Social Services (Quality, Improvement and Regulation) (Northern Ireland) Order 2003(1).

Citation, commencement and interpretation

1.—(1) These Regulations may be cited as the Regulation and Quality Improvement Authority (Fees and Frequency of Inspections) (Amendment) Regulations (Northern Ireland) 2010 and shall come into operation on 29th October 2010.

(2) In these regulations "the principal regulations" means the Regulation and Improvement Authority (Fees and Frequency of Inspections) Regulations (Northern Ireland) 2005(**2**).

Amendment of the Regulation and Improvement Authority (Fees and Frequency of Inspections) Regulations (Northern Ireland) 2005

2.—(1) The principal regulations shall be amended in accordance with the following paragraphs:

- (2) In regulation 3 (Registration fees)
 - (a) After paragraph (1) (c) (3) there shall be inserted the following sub-paragraph —

 - (u) In the case of an application referred to in paragraph (1) (u), int.,

 "(d) in respect of a voluntary adoption agency, shall be nil.".

(3) In regulation 4 (Variation Fees)—

- (a) After paragraph (1) (c) (6) there shall be inserted the following sub-paragraph
 - "(d) in the case of a voluntary adoption agency, nil.";
- (b) After paragraph (2) (c) (7) there shall be inserted the following sub-paragraph
 - "(d) in the case of an application referred to in paragraph (1) (d), nil.";
- (c) After paragraph (3) (c) (8) there shall be inserted the following sub-paragraph
 - "(d) in the case of an application referred to in paragraph (1) (d), nil.".

(4) In regulation 5 (9)there shall be inserted at the end of the Table the following entry in the appropriate columns —

"(5B) An agency, whose premises are used as a voluntary adoption agency, shall be inspected, on a minimum of once every 3 years"
