The Parking Places (Disabled Persons' Vehicles) (Amendment No. 4) Order (Northern Ireland) 2011

Made - - - -

4th April 2011

Coming into operation -

26th April 2011

The Department for Regional Development(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 4) Order (Northern Ireland) 2011 and shall come into operation on 26th April 2011.

2. Schedule 1 to The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2006(d) shall be amended by the addition of the items set out in the Schedule to this Order.

SCHEDULE

Unlimited Waiting

Article 2

- “709. Ballystrudder Gardens, Islandmagee (north side) – from a point 273 metres south-east of its junction with Reids Road, for a distance of 6 metres.
- 710. Glenaan Park, Kells (south-west side) – from a point 120 metres south-west of its junction with Church Road, for a distance of 3 metres in a south-westerly direction.
- 711. Glenarm Road, Larne (west side) – from a point 53 metres south of its junction with Victoria Road for a distance of 5.5 metres.
- 712. Shore Road, Newtownabbey (south-east side) – from a point 12 metres south-west of its junction with Old Manse Road, for a distance of 6.6 metres.
- 713. Shore Road, Newtownabbey (south-east side) – from a point 40 metres north-east of its junction with Circular Road, for a distance of 6.6 metres.
- 714. Armagh Road Estate, Portadown (south-east side) – from a point 22 metres north-east of its junction with Dorchester Drive, for a distance of 3 metres in a north-easterly direction.”

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of road specified in the Schedule.
