AMENDMENTS TO SECONDARY LEGISLATION

**Amendment of the Housing Benefit Regulations**

**19.**—(1) The Housing Benefit Regulations (Northern Ireland) 2006<sup>(1)</sup> are amended in accordance with paragraphs (2) to (7).

(2) In regulation 2(1) (interpretation)—

(a) after the definition of “broad rental market area determination”<sup>(2)</sup> insert—

““the Caxton Foundation” means the charitable trust of that name established on 28<sup>th</sup> March 2011, for the benefit of certain persons suffering from hepatitis C and other persons eligible for payment in accordance with its provisions;” and

(b) in the definition of “qualifying person”<sup>(3)</sup> after “the Skipton Fund” insert “, the Caxton Foundation”.

(4) In regulation 34 (earnings of self-employed earners), in paragraph (1) omit the words beginning “and shall include” to the end of the paragraph.

(c) regulation 72(9)(b)<sup>(6)</sup> (non-dependant deductions);
