1. Introduction

- 1.1. This Explanatory Memorandum has been prepared by the Department of the Environment to accompany the Statutory Rules (details above) which are laid before the Northern Ireland Assembly.
- 1.2. The Statutory Rules are made under Articles 55(1) and (2), 61(2) and (6), 65(1) and (2) and 110(2) of the Road Traffic (Northern Ireland) Order 1995 and are subject to the negative resolution procedure.

2. Purpose

- 2.1. The purpose of these Regulations is to amend the following Regulations to comply with Commission Directive 2010/48/EU.
 - 2.1.1. The Motor Vehicle Testing Regulations (Northern Ireland) 2003.
 - 2.1.2. The Goods Vehicles (Testing) Regulations (Northern Ireland) 2003.
 - 2.1.3. The Motor Vehicles (Construction and Use) Regulations (Northern Ireland) 1999.

3. Background

- 3.1. The Motor Vehicle Testing Regulations (Northern Ireland) 2003 are amended as follows.
 - 3.1.1. Paragraph 2(c) of Schedule 2 is amended by inserting references to hazard warning signals and side marker lamps and end outline marker lamps in the items to be tested.
 - 3.1.2. Schedule 3 is also amended by adding supplementary restraint systems and electronic stability control systems to the list of items to which regard is given during an examination.
- 3.2. The Goods Vehicles (Testing) Regulations (Northern Ireland) 2003 is amended as follows.
 - 3.2.1. To extend the glass transparency requirements currently applicable to cars to include goods vehicles. Two additional items have been added to

the list of items to be inspected as part of a vehicle test. The amendments are in Schedule 3.

3.2.1.1. Item 5 in paragraph 1 is amended to include reference to regulations 36 and 37 and the subject matter to include the word “glass”.

3.2.1.2. Paragraph 6 of Schedule 3 is also amended to add references to supplementary restraint systems and electronic stability control system.

3.3. Regulation 24(5) of the Motor Vehicles (Construction and Use) Regulations (Northern Ireland) 1999 is amended in regards to the efficiency limit for brakes to increase the braking efficiency requirements for vehicles when not towing a trailer from 50% to 58%. This new limit is to apply to vehicles first used from the 1st January 2012.

4. Consultation

4.1. The Department accordingly issued a consultation on 14 November 2011 to 2 January 2012.

5. Equality Impact

5.1. The legislative changes were subject to an Equality Impact Screening assessment, and were assessed as having no impact on any Section 75 groups. No further equality assessments were therefore carried out.

6. Regulatory Impact

6.1. The legislative changes will have no measurable impact on the voluntary, private or public sectors, therefore an full Impact Assessment was not considered to be required.

7. Financial Implications

7.1. There are no proposals to increase test fees to address these changes and accordingly no cost implications for the motoring public.

8. Section 24 of the Northern Ireland Act 1998

8.1. The proposed legislation is considered compatible with section 24 of the Northern Ireland Act 1998.

9. EU Implications

9.1. The legislative changes make the minimum necessary amendments to ensure the implementation of Commission Directive 2010/48/EU.

10. Parity or Replicatory Measure

10.1. The legislative changes will ensure that vehicle testing in Northern Ireland remains identical to vehicle testing in Great Britain.
