**The Plant Health (Amendment No.2) Order (Northern Ireland)  
2012**

*Made* - - - - - *18th June 2012*

*Coming into operation* - *16th July 2012*

The Department of Agriculture and Rural Development<sup>(a)</sup> makes the following Order, in exercise of the powers conferred by sections 2, 3 and 4(1) of the Plant Health Act (Northern Ireland) 1967<sup>(b)</sup>.

**Citation and commencement**

1. This Order may be cited as The Plant Health (Amendment No.2) Order (Northern Ireland) 2012 and comes into operation on 16th July 2012.

**Amendments to the Plant Health Order (Northern Ireland) 2006**

2. Schedule 8(c) (Swiss plant passports), to the Plant Health Order (Northern Ireland) 2006<sup>(d)</sup> is amended in accordance with Article 3.

**Switzerland**

3.—(1) In Part A—

(a) for paragraph 1 substitute—

“1. Plants, other than seeds, of *Beta vulgaris* L., *Camellia* sp., *Humulus lupulus* L., *Virurnum* spp., *Prunus* L. not including *Prunus laurocerasus* L. or *Prunus lusitanica* L., and *Rhododendron* spp. not including *Rhododendron simsii* Planch, intended for planting.”; and

(b) in paragraph 5, after sub-paragraph (e) insert—

“(ea) plants of *Palmae*, intended for planting and having a diameter of the stem at the base of over 5cm and belonging to the following genera or species: *Areca catechu* L., *Arenga pinnata* (Wurmb) Merr., *Borassus flabellifer* L., *Brahea* Mart., *Butia* Becc., *Calamus merrillii* Becc., *Caryota maxima* Blume ex Mart., *Caryota cumingii* Lodd. ex Mart., *Chamaerops* L., *Cocos nucifera* L., *Corypha elata* Roxb., *Corypha gebang* Mart., *Elaeis guineensis* Jacq., *Jubaea* Kunth., *Livistona* r. Br.,

(2) In Part B—

(a) for paragraph 1 substitute—

“1. Plants, other than seeds, intended for planting, other than *Clausena* Burm. f. and *Murraya* Koenig ex L.”; and

(b) In paragraph 5(c), for “*Quercus* L. or *Solidago* L.” substitute “*Quercus* L., *Rhododendron* spp., not including *Rhododendron simsii* Planch, *Solidago* L., or *Viburnum* spp.”.

*(This note is not part of the Regulations)*

Article 3 makes amendments to the Plant Health Order (Northern Ireland) 2006 to enforce Decision 1/2010 of the Joint Committee on Agriculture (2011/83/EU)(OJ No. L 32,8.2.2011, p.9) which relates to plant health controls on trade in plant material with Switzerland.

An impact assessment has not been produced for this instrument as no impact on business or the private or voluntary sector is foreseen.
