**The Prohibition of Waiting (Amendment) Order (Northern  
Ireland) 2012**

*Made* - - - - - *25th September 2012*

*Coming into operation* - *17th October 2012*

The Department for Regional Development<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

**Citation and commencement**

1. This Order may be cited as The Prohibition of Waiting (Amendment) Order (Northern Ireland) 2012 and shall come into operation on 17th October 2012.

**Amendment**

2. The Prohibition of Waiting Order (Northern Ireland) 2001<sup>(d)</sup> shall be amended by the addition to Schedule 2 of the following items—

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order further amends the Prohibition of Waiting Order (Northern Ireland) 2001 (“the Order”). The amendments prohibit waiting by vehicles, with certain exceptions, on lengths of North Road, Ballymoney, at the times and on the days and during the period specified (Article 2).

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the road.
