ROAD TRAFFIC AND VEHICLES

The Parking Places (Disabled Persons' Vehicles) (Amendment No. 6) Order (Northern Ireland) 2012

Made - - - - - *28th September 2012*

Coming into operation - *22nd October 2012*

The Department for Regional Development(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedules.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objections or other representations have been received.

Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 6) Order (Northern Ireland) 2012 and shall come into operation on 22nd October 2012.

Amendments

2.—(1) The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2006(a) shall be amended in accordance with paragraphs (2) to (4).

(2) Delete the following items from Schedule 1—

- (a) item no. 344 relating to Orangefield Drive, Armagh;
- (b) item no. 504 relating to Bloomfield Avenue, Belfast;
- (c) item no. 164 relating to Connsbrook Avenue, Belfast;
- (d) item no. 436 relating to Willowfield Parade, Belfast; and
- (e) item no. 63 relating to Hanover Street, Portadown.

(3) Add to Schedule 1 the items set out in Schedule 1 to this Order.

(4) Add to Schedule 2 the item set out in Schedule 2 to this Order.

3.—(1) Schedule 1 to The Parking Places on Roads (Disabled Persons' Vehicles) Order (Northern Ireland) 2006(b) shall be amended in accordance with paragraph (2).

(2) Delete the following items—

- (a) item no. 265 relating to Dromore Street, Belfast; and
- (b) item no. 1338 relating to Hobson Park, Portadown.

SCHEDULE 1

Article 2 (3)

Unlimited Waiting

- “870. Park Avenue, Bangor (south-west side) – from a point 15 metres north-west of its junction with Park Drive for a distance of 5.2 metres.
- 871. Elm Street, Belfast (south side) – from a point 12 metres east of its junction with Virginia Street, for a distance of 3.5 metres in an easterly direction.
- 872. Hillview Avenue, Belfast (west side) – from a point 89 metres south of its junction with Upper Newtownards Road, for a distance of 5.5 metres in a southerly direction.
- 873. North Parade, Belfast (south side) – from a point 36 metres east of its junction with Cross Parade, for a distance of 6.6 metres in an easterly direction.
- 874. River Terrace, Belfast (west side) – from a point 166 metres north of its junction with Cooke Street, for a distance of 5.5 metres in a northerly direction.
- 875. Willowfield Parade, Belfast (south side) – from a point 18.5 metres east of its junction with Willowfield Avenue, for a distance of 5.5 metres in an easterly direction.
- 876. Windsor Road, Belfast (north side) – from a point 51 metres west of its junction with Lisburn Road, for a distance of 5.5 metres in a westerly direction.
- 877. Orritor Street, Cookstown (south side) – from a point 36.5 metres west of its eastern junction with Orritor Crescent, for a distance of 6.5 metres.
- 878. Enler Park West, Dundonald (north side) – from a point 117 metres north-west of its junction with Enler Park, for a distance of 4.2 metres in a northerly direction.
- 879. Downshire Road, Holywood (north-east side) – from a point 3.7 metres north-west of its junction with Downshire Place, for a distance of 5 metres.
- 880. Seahill Road, Larne (west side, to the rear of No. 63 Hillmount Gardens) – from a point 108 metres south of its junction with Britannia Crescent, for a distance of 5.5 metres.
- 881. Hill Street, Lisburn (south-east side in the layby in front of No. 60) – from a point 6 metres south-west of its junction with Hill Street for a distance of 5.4 metres in a south-westerly direction.
- 882. Hill Street, Milford (east side) – from a point 89 metres south of its junction with Monaghan Street, for a distance of 6 metres.
- 883. Bridge Street, Newtownbutler (west side) – from a point 24 metres south of its junction with Main Street, for a distance of 6 metres in a southerly direction.
- 884. Shandon Park, Omagh (north-east side) – from a point 85 metres north-east of its junction with Tamlaght Road, for a distance of 6.5 metres.
- 885. Hobson Park, Portadown (south-west side) – from a point 125 metres south-west of its junction with Old Rectory Park, for a distance of 6 metres.
- 886. Church Street, Tandragee (east side) – from a point 60 metres south of its junction with Montague Street, for a distance of 3 metres.”

SCHEDULE 2

Article 2 (4)

Waiting limited to 3 hours on Monday to Saturday between 8.00 a.m. and 6.30 p.m. with return prohibited within 1 hour or 6.30 p.m.

- “12. Carlisle Road, Londonderry (south-east side) – from a point 15 metres north-east of its junction with Grove Place, for a distance of 6 metres in a north-easterly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2006 and The Parking Places on Roads (Disabled Persons' Vehicles) Order (Northern Ireland) 2006.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the road specified in Schedule 1, the introduction of a parking place with waiting limited to 3 hours on Monday to Saturday between 8.00 a.m. and 6.30 p.m. with no return permitted within 1 hour or 6.30 p.m. on the length of road specified in Schedule 2 and the removal of the parking places referred to in Articles 2(2) and 3(2).
