The Department of Agriculture and Rural Development, makes the following Order in exercise of the powers conferred by section 39(1) of the Forestry Act (Northern Ireland) 2010(a).

**Citation and interpretation**

1.—(1) This Order may be cited as the Forestry (2010 Act) (Commencement No. 3) Order (Northern Ireland) 2013.

(2) In this Order “the Act” means the Forestry Act (Northern Ireland) 2010.

**Appointed Day**

2. 17th June 2013 is the day appointed for the coming into operation of the provisions of the Act listed in the Schedule.
