## The Social Security (Miscellaneous Amendments) Regulations (Northern Ireland) 2014

## **Amendment of the State Pension Credit Regulations**

- **5.**—(1) The State Pension Credit Regulations (Northern Ireland) 2003(1) are amended in accordance with paragraphs (2) to (6).
  - (2) In regulation 1 (citation, commencement and interpretation)—
    - (a) in paragraph (2) omit the definition of "service user group" (2); and
    - (b) after paragraph (3) insert—
      - "(3A) References in these Regulations to a claimant participating as a service user are to—
        - (a) a person who is being consulted by or on behalf of—
          - (i) a body which has a statutory duty to provide services in the field of health, social care or social housing, or
          - (ii) a body which conducts research or undertakes monitoring for the purpose of planning or improving such services,
          - in their capacity as a user, potential user, carer of a user or person otherwise affected by the provision of those services; or
        - (b) the carer of a person consulted under sub-paragraph (a).".
- (3) In regulation 17A(3)(f)(3) (earnings of employed earners) for "claimant's participation in a service user group" substitute "claimant participating as a service user".
- (4) In regulation 18(7A)(4) (notional income) for "claimant's participation in a service user group" substitute "claimant participating as a service user".
- (5) In regulation 24(3)(5) (income paid to third parties) for "claimant's participation in a service user group" substitute "claimant participating as a service user".
- (6) In paragraph 9(2B)(6) (the standard rate) of Schedule 2 (housing costs) for "0.5%" substitute "0.5 percentage points".
