Citation and commencement

1. This Order may be cited as the Brucellosis Control (Amendment) Order (Northern Ireland) 2014 and shall come into operation on 3rd November 2014.

Amendment of the Brucellosis Control Order (Northern Ireland) 2004

2. The Brucellosis Control Order (Northern Ireland) 2004 ^{M3} shall be amended as follows—
- (a) In Article 5(1)(a) for the number “12” there shall be substituted the number “ 24 ”.
- (b) In Articles 5 and 20 for each occurrence of the number “30” there shall be substituted the number “ 60 ”.
