PART 2 N.I.

Modification of contracting-out provisions

Application of this Part N.I.

- 3. This Part applies where—
 - (a) an election is made under section 7 (elections as to employments covered by contractingout certificates) of the 1993 Act(1)in relation to persons who become members of the new scheme on or after 1st April 2015 and before 6th April 2016 (whether or not any of those persons are members of an old scheme); and
 - (b) the new scheme satisfies the requirements of section 5 (requirements for certification of schemes) of the 1993 Act(2).

Contracting-out N.I.

- **4.**—(1) Part 2 of the Occupational Pension Schemes (Contracting-out) Regulations (Northern Ireland) 1996(3)(certification of employments) is modified as follows in its application to the new scheme.
- (2) The requirements in regulation 2(1)(a) (making of elections for the issue of contractingout certificates) and regulations 3 (notices by employers of intended election) to 5 (time for making an election) do not apply.
 - (3) In regulation 6 (information to be included in an election)—
 - (a) paragraph (1) is to be read as though, for sub-paragraphs (a) to (f), there were substituted—
