The Optical Charges and Payments (Amendment) Regulations (Northern Ireland) 2015

Citation, commencement and interpretation

- 1.—(1) These Regulations may be cited as the Optical Charges and Payments (Amendment) Regulations (Northern Ireland) 2015 and shall come into operation on 29th June 2015.
- (2) In these Regulations "the principal Regulations" means the Health and Personal Social Services (Optical Charges and Payments) Regulations (Northern Ireland) 1997(1).

Amendment of regulation 19 of the principal Regulations

- **2.** In regulation 19 of the principal Regulations (redemption value of voucher for replacement or repair)—
 - (a) in paragraph (1)(b) for "£55.80" substitute "£56.40"; and
 - (b) in paragraph (3) for "£14.40" substitute "£14.50".

Amendments of the Schedules to the principal Regulations

3.—(1) In Schedule 1 to the principal Regulations (voucher letter codes and face values – supply and replacement)(2), in column 3 (face value of voucher), for each amount specified in column 1 of the Table below (old amount) substitute the amount specified in relation to it in column 2 of that Table (new amount).

- (2) In Schedule 2 to the principal Regulations (prisms, tints, photochromic lenses, small and special glasses and complex appliances)—
 - (a) in paragraph 1(1)(a) (prism single vision lens) for "£12.40" substitute "£12.50";
 - (b) in paragraph 1(1)(b) (prism other lens) for "£15.00" substitute "£15.20";
 - (c) in paragraph 1(1)(e) (small glasses)—
 - (i) in sub-head (i) for "£63.00" substitute "£63.60";
 - (ii) in sub-head (ii) for "£55.80" substitute "£56.40";
 - (iii) in sub-head (iii) for "£30.20" substitute "£ 30.50";
 - (d) in paragraph 1(1)(g) (specially manufactured frames) for "£63.00" substitute "£63.60";
 - (e) in paragraph 2(a) (minimum complex appliance payment single vision lenses) for "£14.40" substitute "£14.50"; and
 - (f) in paragraph 2(b) (minimum complex appliance payment other cases) for "£36.60" substitute "£37.00".
- (3) For Schedule 3 to the principal Regulations (voucher value repair)(3), substitute Schedule 3 as set out in the Schedule to these Regulations.

Application of Regulations 2 and 3

4. The amendments made in regulations 2 and 3 apply only in relation to a voucher accepted or used pursuant to regulation 12 or regulation 17 of the principal Regulations on or after 29th June 2015.
