# The Carnbane Road, Newry (Abandonment) Order (Northern Ireland) 2015

Made---2nd December 2015Coming into operation-10th February 2016

The Department for Regional Development( $\mathbf{a}$ ) makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of the Roads (Northern Ireland) Order 1993( $\mathbf{b}$ ) and now vested in it( $\mathbf{c}$ ).

The Department in accordance with Article 68(4) of that Order proposes to abandon the areas of road described in the Schedule as they are not necessary.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

#### **Citation and commencement**

**1.** This Order may be cited as The Carnbane Road, Newry (Abandonment) Order (Northern Ireland) 2015 and shall come into operation on 10th February 2016.

#### Application

2. The areas of road described in the Schedule are abandoned.

**3.**—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned areas of road shall be retained.

(2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.


#### AREAS OF ROAD TO BE ABANDONED

Two areas of superseded road at Carnbane Road, Newry totalling 1525 square metres, consisting of—

- (a) 903 square metres of road commencing at a point 36 metres from the junction of the U5160 Carnbane Road, extending 69 metres in a south-easterly direction and ending at a point 6 metres from the A27 Shepherds Way; and
- (b) 622 square metres of road commencing at a point 4 metres from the A27 Shepherds Way, extending 58 metres in a south-easterly direction and ending at a point 28.5 metres from its junction with the A27 Tandragee Road;

more particularly delineated and shown hatched on Map No. DR1/14/490114.
