ROAD TRAFFIC AND VEHICLES

The Parking Places on Roads (Disabled Persons' Vehicles) (Amendment No. 4) Order (Northern Ireland) 2015

Made---21st December 2015Coming into operation-14th January 2016

The Department for Regional Development(\mathbf{a}) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997(\mathbf{b}) and now vested in it(\mathbf{c}).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No objections or other representations have been received.

Citation and commencement

1. This Order may be cited as The Parking Places on Roads (Disabled Persons' Vehicles) (Amendment No. 4) Order (Northern Ireland) 2015 and shall come into operation on 14th January 2016.

Unlimited Waiting

- "2314. Dunvegan Street, Belfast (south side) from a point 94 metres west of its junction with Ravenhill Road, for a distance of 5.5 metres in a westerly direction.
- 2315. Sefton Drive, Belfast (west side) from a point 15 metres north of its junction with Pim's Avenue, for a distance of 5.5 metres in a northerly direction.
- 2316. Pinewood Avenue, Carrickfergus (north-east side) from a point 34 metres north-west of its junction with Sandes Court, for a distance of 5.5 metres in a north-westerly direction.
- 2317. Brook Place, Circular Road, Coleraine (south side) from a point 25 metres east of its junction with Brook Street, for a distance of 6.5 metres in an easterly direction.
- 2318. Glenkeen Avenue, Greenisland (south-west side of the parking area) from a point 115 metres north-west of its junction with Knocksallagh Park, for a distance of 3 metres in a south-westerly direction..
- 2319. Kinbayne Crescent, Greenisland (south-east side) from a point 27 metres south-west of its junction with Kinbayne Avenue, for a distance of 3 metres in a south-westerly direction.
- 2320. Bank Road, Larne (north-east side) from a point 73 metres south-east of its junction with Glynn Road, for a distance of 5.5 metres in a south-easterly direction.
- 2321. Glynn Road, Larne (south-west side) from a point 39 metres north-west of its junction with Bank Road, for a distance of 5.5 metres in a north-westerly direction.
- 2322. Old Glenarm Road, Larne (west side) from a point 25 metres south of its junction with Herbert Avenue, for a distance of 5.5 metres in a southerly direction.
- 2323. Columbcille Court, Londonderry (south side) from a point 116 metres south-east of its junction with Abbey Street, for a distance of 2.5 metres in a south-westerly direction."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places on Roads (Disabled Persons' Vehicles) Order (Northern Ireland) 2015 by the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule and the removal of the parking places referred to in Article 2(2).

The Order also amends The Parking Places on Roads (Belfast City Centre) Order (Northern Ireland) 2012 by the deletion of Schedules 4, 5 and 6.
