The Shared Parental Leave Regulations (Northern Ireland) 2015

Made - - - - *2nd March 2015*

Coming into operation *15th March 2015*

The Department for Employment and Learning makes the following Regulations in exercise of the powers conferred by Articles 70C(2), 107E, 107F(1), (4), (7) to (14), and (16), 107G(1) to (6), 107H(1) and (3), 107I(1), (4), (7) to (14), and (16), 107K(1), (4), and (5), 107L, 107M(1) and 131 of the Employment Rights (Northern Ireland) Order 1996 ^{M1}.
