Citation and interpretation

 - (b) section 3 (window displays not to constitute occupation under the 1977 Order in certain cases).

- **3.** 19th September 2016 is the appointed day for the coming into operation of the following provisions of the 2016 Act—
 - (a) section 4 (repeals); and
 - (b) Schedule (repeals).
