The Zoonoses (Fees) (Amendment) Regulations (Northern Ireland) 2016

Made - - - - 25th February 2016

Coming into operation - 1st April 2016

The Department of Agriculture and Rural Development is designated(**a**) for the purposes of section 2(2) of the European Communities Act 1972(**b**) in relation to the common agricultural policy of the European Union.

These Regulations make provision for a purpose mentioned in section 2(2) of that Act and it appears to the Department that it is expedient for references to Regulation (EC) No 2160/2003 of the European Parliament and of the Council on the control of salmonella and other specified foodborne zoonotic agents(c), and for certain provisions of other European instruments to be construed as references to that Regulation and those provisions as amended from time to time.

The Department of Agriculture and Rural Development makes the following Regulations in exercise of the powers conferred by section 2(2) of, as read with paragraph 1A of Schedule $2(\mathbf{d})$ to, the European Communities Act 1972 and section 56(1), (2) and (5) of the Finance Act $1973(\mathbf{e})$.

In accordance with section 56(1) and (5) of the Finance Act 1973, the Department of Finance and Personnel consents to the making of these Regulations.

Citation, commencement and interpretation

- 1.—(1) These Regulations may be cited as the Zoonoses (Fees) (Amendment) Regulations (Northern Ireland) 2016 and come into operation on 1st April 2016.
- (2) The Interpretation Act (Northern Ireland) 1954(**f**) shall apply to these Regulations as it shall apply to an Act of the Assembly.

Amendment of the Zoonoses (Fees) Regulations (Northern Ireland) 2011

2.—(1) The Zoonoses (Fees) Regulations (Northern Ireland) 2011(**g**) are amended in accordance with paragraph (2).
