**The Public Service Vehicles (International Passenger Services) Regulations (Northern Ireland) 2019**

*Made - - - - 4th March 2019*

*Coming into operation 28th March 2019*

The Department for Infrastructure<sup>(1)</sup> makes the following Regulations in exercise of the powers conferred by section 2(2) of the European Communities Act 1972<sup>(2)</sup> and section 56(1) and (5) of the Finance Act 1973<sup>(3)</sup>.

The Department for Infrastructure is designated<sup>(4)</sup> for the purposes of section 2(2) of the European Communities Act 1972 in relation to measures relating to the carriage of passengers and goods by road.

In accordance with section 56(1) and (5) of the Finance Act 1973, the Department of Finance<sup>(5)</sup> consents to the making of these Regulations.
