# The Seed Marketing (Amendment) (No. 2) Regulations (Northern Ireland) 2020

Made	-	10th December 2020
Coming into operation	-	27th December 2020

The Department of Agriculture, Environment and Rural Affairs being a Department designated( $\mathbf{a}$ ) for the purposes of the European Communities Act 1972( $\mathbf{b}$ ) in relation to the common agricultural policy of the European Union makes the following Regulations in exercise of the powers conferred by section 2(2) of that Act.

#### Citation and commencement

**1.** These Regulations may be cited as the Seed Marketing (Amendment) (No. 2) Regulations (Northern Ireland) 2020 and come into operation on 27th December 2020.

### Amendment of the Seed Marketing (Amendment) Regulations (Northern Ireland) 2020

**2.** In regulation 1 of the Seed Marketing (Amendment) Regulations (Northern Ireland) 2020(c), for "come into operation" until the end, substitute "come into operation on 28th December 2020.".
