The Department of Health M1 , makes the following Regulations in exercise of the powers conferred by sections 25C(1), (3)(c), (4)(d) and 25F(2) of the Public Health Act (Northern Ireland) 1967 M2 .

These Regulations are made in response to the serious and imminent threat to public health which is posed by the incidence and spread of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) in Northern Ireland.

The Department of Health considers that the restrictions and requirements imposed by these Regulations are proportionate to what they seek to achieve, which is a public health response to that threat.

In accordance with section 25Q of that Act the Department of Health is of the opinion that, by reason of urgency, it is necessary to make these Regulations without a draft having been laid before, and approved by a resolution of, the Assembly.

Citation, commencement and interpretation

- 1.—(1) These Regulations may be cited as the Health Protection (Coronavirus, Restrictions) Regulations (Northern Ireland) 2020 and shall come into operation at 11.00 p.m. on 28th March 2020.
 - (2) In these Regulations—

[F1"childcare" includes day care as defined in Article 19 of the Children (Northern Ireland) Order 1995;]

"coronavirus" means severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2);

[F1" elite athlete" means an individual who—

- (i) derives a living from competing in a sport,
- (ii) plays in a professional league or competition,
- (iii) is a senior representative nominated by a relevant sporting body,
- (iv) is a member of the senior training squad for a relevant sporting body, or
- (v) is aged 16 or above and on an elite development pathway.

For the purposes of the definition of "elite athlete"—

- (a) "elite development pathway" means a development pathway established by the national governing body of a sport to prepare athletes—
 - (i) so that they may derive a living from competing in that sport, or
 - (ii) to compete at that sport at the Tokyo or Beijing Olympic or Paralympic Games, or, if that sport is not part of the Tokyo Olympic and Paralympic Games programme, in the Commonwealth Games to be held in Birmingham;
- (b) "relevant sporting body" means the national governing body of a sport which may nominate athletes to represent—
 - (i) Great Britain and Northern Ireland or Ireland at the Tokyo or Beijing Olympic or Paralympic Games, or
 - (ii) England, Wales, Scotland, Northern Ireland, Gibraltar, Guernsey, Jersey or the Isle of Man at the Commonwealth Games to be held in Birmingham in those sports which are not part of the Tokyo Olympic and Paralympic Games programme;
- (c) "Senior representative" means an individual who is considered by a relevant sporting body to be a candidate to qualify to compete on behalf of—
 - (i) Great Britain and Northern Ireland or Ireland at the Tokyo or Beijing Olympic or Paralympic Games;
 - (ii) England, Wales, Scotland, Northern Ireland, Gibraltar, Guernsey, Jersey or the Isle of Man at the Commonwealth Games to be held in Birmingham in those sports which are not part of the Tokyo Olympic and Paralympic Games programme.]

"person responsible for carrying on a business" includes the owner, proprietor and manager of that business;

"vulnerable person" includes—

- (a) any person aged 70 or older;
- (b) any person under 70 who has an underlying health condition, including but not limited to, the conditions listed in Schedule 1;
- (c) any person who is pregnant.

The emergency period and review of need for restrictions

- 2.—(1) For the purposes of these Regulations, the "emergency period"—
 - (a) starts when these Regulations come into operation, and
 - (b) ends in relation to a restriction or requirement imposed by these Regulations on the day and at the time specified in a direction published by the Department of Health terminating the requirement or restriction.
- (2) The Department of Health must review the need for restrictions and requirements imposed by these Regulations at least once every 21 days, with the first review being carried out by 18th April 2020.
- (3) As soon as the Department of Health considers that any restrictions or requirements set out in these Regulations are no longer necessary to prevent, protect against, control or provide a public health response to the incidence or spread of infection in Northern Ireland with the coronavirus, the Department of Health must publish a direction terminating that restriction or requirement.
 - (4) A direction published under this regulation may—
 - (a) terminate any one or more requirement or restriction;
 - (b) terminate a requirement or restriction in relation to a specified business or service or a specified description or business or service.

 - (5) In this regulation, "specified" means specified in a direction published under this regulation.

Requirement to close premises and businesses during the emergency

- **3.**—(1) A person responsible for carrying on a business which is listed in Part 1 of Schedule 2 must—
 - (a) during the emergency period—

- (i) close any premises, or part of the premises, in which food or drink are sold for consumption on those premises, and
- (ii) cease selling food or drink for consumption on its premises; or
- (b) if the business sells food or drink for consumption off the premises, cease selling food or drink for consumption on its premises during the emergency period.
- (2) For the purposes of paragraph 1(a), food or drink sold by a hotel or other accommodation as part of room service is not to be treated as being sold for consumption on its premises.
- (3) For the purposes of paragraph (1)(a)(ii) and (b), an area adjacent to the premises of the business where seating is made available for customers of the business (whether or not by the business) is to be treated as part of the premises of that business.
- (4) A person responsible for carrying on a business or providing a service which is listed in Part 2 of Schedule 2 must cease to carry on that business or to provide that service during the emergency period.
 - (5) Paragraph (4) does not prevent the use of—
 - (a) premises used for the businesses or services listed in paragraphs 5, 6, 8, 9 or 10 of that Part to broadcast a performance to people outside the premises, whether over the internet or as part of a radio or television broadcast;
 - (b) any suitable premises used for the businesses or services listed in that Schedule to host blood donation sessions.
 - [F4(c)] premises used for the businesses listed in paragraphs 5, 6, 7, 9 or 10 of that Part to screen a film or to stage a live music concert or theatre performance outdoor to persons who are present in a vehicle parked on the premises, subject to the person responsible for the business taking all reasonable measures to ensure that—
 - (i) all those who attend for this purpose remain inside the vehicle in which they arrived at the premises for the duration of the film or live concert or performance; and
 - (ii) the occupants of each vehicle are members of the same household.]
- (6) If a business listed in Part 1 or 2 of Schedule 2 ("business A") forms part of a larger business ("business B"), the person responsible for carrying on business B complies with the requirement in paragraph (1) if it closes down business A.

Further restrictions and closures during the emergency period

- **4.**—[F5(1) A person responsible for providing library services must, during the emergency period—
 - (a) cease to do so, except by providing services in response to orders or enquiries received—
 - (i) through a website, or otherwise by on-line communication,
 - (ii) by telephone, including orders by text message, or
 - (iii) by post;

- (b) close any premises which are not required to provide its services as permitted by sub-paragraph (a);
- (c) cease to admit any person to its premises who is not required to provide its services as permitted by sub-paragraph (a).
- (2) During the emergency period, a person responsible for carrying on a business listed in Part 3 of Schedule 2 may offer goods for sale or for hire in a shop, but may not provide a service listed in paragraph 13, 14, 15 or 16 of Part 2 of Schedule 2.]
- (3) Subject to paragraph (4), a person responsible for carrying on a business consisting of the provision of holiday accommodation, whether in a hotel, hostel, bed and breakfast accommodation ^{F6}... or boarding house, must cease to carry on that business during the emergency period.
- (4) A person referred to in paragraph (3) may continue to carry on their business and keep any premises used in that business open—
 - (a) to provide accommodation for any person, who—
 - (i) is unable to return to their main residence;
 - (ii) uses that accommodation as their main residence;
 - (iii) needs accommodation while moving house;
 - (iv) needs accommodation to attend a funeral;
 - [F7(v) is an elite athlete or the coach of an elite athlete or the parent of an elite athlete who is under the age of 18 and needs accommodation for the purpose of training;]
 - (b) to provide accommodation or support services for the homeless,
 - (c) to host blood donation sessions, F8...
 - (d) for any purpose requested by any Northern Ireland department, the Regional Agency, a health and social care trust or a district council [F9]; or
 - (e) to provide services (other than accommodation) in response to enquiries or bookings received—
 - (i) through a website or otherwise by on-line communication,
 - (ii) by telephone, including text message, or
 - (iii) by post.]
- (5) A person who is responsible for a place of worship must ensure that, during the emergency period, the place of worship is closed, except for uses permitted in paragraph (6).
 - (6) A place of worship may be used—
 - (a) for funerals,
 - (b) to broadcast an act of worship, whether over the internet or as part of a radio or television broadcast, or
 - (c) to provide essential voluntary services or urgent public support services [F10] upon the request of the Department of Health] (including the provision of food banks or other support for the homeless or vulnerable people, blood donation sessions or support in an emergency).
 - [FII(d)] to solemnise a marriage ceremony where a party to the marriage is suffering from a progressive disease, where death in consequence of that disease can reasonably be expected within six months of the date of the ceremony and subject to a total number of ten persons being present in the place of worship at the time of the ceremony, including the marriage celebrant and the two parties to the marriage.]
 - [F12(e) for acts of private worship;

- (f) to broadcast (by way of loudspeaker or radio) an act of worship to worshippers who are present in a vehicle parked on the premises, subject to the person responsible for the place of worship taking all reasonable measures to ensure that—
 - (i) all those who attend for this purpose remain inside the vehicle in which they arrived at the premises for the duration of the service; and
 - (ii) the occupants of each vehicle are members of the same household.]
- [F13(g) to solemnise a marriage ceremony, subject to—
 - (i) the ceremony taking place outdoors; and
 - (ii) a total number of ten persons being present in the place of worship at the time of the ceremony, including the marriage celebrant and the two parties to the marriage.]

- [F15(7)] A person who is responsible for a community centre must ensure that, during the emergency period, the community centre is closed except where it is used to provide—
 - (a) essential voluntary activities or urgent public support services upon the request of the Department of Health (including the provision of food banks or other support for the homeless or vulnerable people, blood donation sessions or support in an emergency); or
 - (b) childcare provided by a person who is registered in accordance with Part XI of the Children (Northern Ireland) Order 1995.]
- (8) A person who is responsible for a crematorium ^{F16}... must ensure that, during the emergency period, the crematorium ^{F16}... is closed to members of the public, except for funerals ^{F16}....
- (9) If a business referred to in paragraph (1) or (3) ("business A") forms part of a larger business ("business B"), the person responsible for carrying on business B complies with the requirement in paragraph (1) or (3) to cease to carry on its business if it ceases to carry on business A.

4A. During the emergency period, a person who is responsible for a burial ground must take all reasonable measures to ensure that a distance of at least two metres is maintained between every person at the burial ground (except between members of the same household).]

Restrictions on movement

- **5.**—(1) During the emergency period, no person may leave the place where they are living without reasonable excuse.
 - (2) For the purposes of paragraph (1), a reasonable excuse includes the need—
 - [F18(a) to obtain goods from any business listed in Part 3 of Schedule 2;]
 - (b) to take exercise either alone or with other members of their household;
 - (c) to seek medical assistance, including to access any of the services referred to in paragraph 37 or 38 of Schedule 2;
 - (d) to provide care or assistance, including relevant personal care within the meaning of paragraph 7(3B) of Schedule 2 to the Safeguarding Vulnerable Groups (Northern Ireland) Order 2007 ^{M3}, to a vulnerable person, or to provide emergency assistance;
 - (e) to donate blood
 - (f) to travel for the purposes of work or to provide voluntary or charitable services, where it is not reasonably possible for that person to work, or to provide those services, from the place where they are living;
 - (g) to attend a funeral of—
 - (i) a member of the person's household,
 - (ii) a close family member, or
 - (iii) if no-one within sub-paragraphs (i) or (ii) is attending, a friend;

- [F19(ga) to visit a burial ground to pay respects to a member of the person's household, family member or friend;]
 - (h) to fulfil a legal obligation, including attending court or satisfying bail conditions, or to participate in legal proceedings;
 - (i) to access critical public services, including—
 - (i) childcare or educational facilities (where these are still available to a child in relation to whom that person is the parent, or has parental responsibility for, or care of the child);
 - (ii) social care services;
 - (iii) services provided by the Department for Communities;
 - (iv) services provided to victims (such as victims of crime);
 - $[^{F20}(v)]$ services provided by a district council or other public body, including household waste or recycling centres;]
 - (j) in relation to children who do not live in the same household as their parents, or one of their parents, to continue existing arrangements for access to, and contact between, parents and children, and for the purposes of this paragraph, "parent" includes a person who is not a parent of the child, but who has parental responsibility for, or who has care of the child;
 - (k) in the case of a minister of religion or worship leader, to go to their place of worship;
- [F21(]) to move house and to undertake associated activities for that purpose, including visiting estate agents, viewing properties and making arrangements for removals;]
 - (m) to avoid injury or illness or to escape a risk of harm.
- [F22(n)] to attend a place of worship for an act of private worship, or to attend an act of worship which is being broadcast or to attend or participate in a marriage ceremony, in accordance with regulation 4(6)(d);
 - (0) to take part in an outdoor activity [F23 including an activity undertaken in or by an outdoor sports facility;]
 - (p) to take part in an outdoor gathering, in accordance with regulation 6A.]

 - (x) to attend a visitor attraction;

- (3) For the purposes of paragraph (1), the place where a person is living includes the premises where they live together with any garden, yard, passage, stair, garage, outhouse or other appurtenance of such premises.
 - (4) Paragraph (1) does not apply to any person who is homeless.

- 7.—(1) A relevant person may take such action as is necessary to enforce any requirement imposed by [F40 regulation 3, 4, 6, 6A or 6B].

Offences and penalties

Fixed penalty notices

- **9.**—(1) An authorised person may issue a fixed penalty notice to anyone that the authorised person reasonably believes—
 - (a) has committed an offence under these Regulations;
 - (b) $[^{F53}$ is aged 18 or over].
- (2) A fixed penalty notice is a notice offering the person to whom it is issued the opportunity of discharging any liability to conviction for the offence by payment of a fixed penalty to the [F54] authority specified in the notice].

[F55(2A) The authority specified in the notice must be—

- (a) in the case of a notice issued by a person designated in accordance with paragraph (10) (ii), the district council in whose area the offence is alleged to have been committed, or
- (b) in the case of a notice issued by a constable, the clerk of petty sessions.]
- (3) Where a person is issued with a notice under this regulation in respect of an offence—
 - (a) no proceedings may be taken for the offence before the end of the period of 28 days following the date of the notice;

Registration of penalty

- **12.**—(1) Where the clerk of petty sessions receives a registration certificate in respect of any sum payable in default, the clerk must register that sum for enforcement as a fine by entering it in the Order Book of a court of summary jurisdiction.
- (2) On registering any sum under this regulation for enforcement as a fine, the clerk of petty sessions must give to the defaulter notice of registration—
 - (a) specifying the amount of that sum and requiring payment of it by such date, not less than 28 days from the date of registration, as may be specified in the notice; and
 - (b) giving the information with respect to the offence included in the registration certificate by virtue of regulation 11(5)(a).

Challenge to notice

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations require the closure of businesses selling food or drink for consumption on the premises, and businesses listed in Part 2 of Schedule 2, to protect against the risks to public health arising from coronavirus, except for limited permitted uses. Businesses offering goods for sale or for hire listed in Part 3 of Schedule 2, are permitted to remain open. The Regulations also prohibit anyone leaving the place where they live without reasonable excuse, and ban public gatherings of more than two people. The closures and restrictions last until they are terminated by a direction given by the Department of Health.

The need for these restrictions must be reviewed by the Department of Health every 21 days, with the first review taking place by 18th April 2020.

No impact assessment has been prepared for these Regulations.
