# The Rates (Small Business Hereditament Relief) (Amendment) Regulations (Northern Ireland) 2020

Made - - - - 1st June 2020

Coming into operation - 23rd June 2020

The Department of Finance(a) makes the following Regulations in exercise of the powers conferred by Article 31C of the Rates (Northern Ireland) Order 1977(b).

#### Citation and commencement

**1.** These Regulations may be cited as the Rates (Small Business Hereditament Relief) (Amendment) Regulations (Northern Ireland) 2020 and shall come into operation on 23rd June 2020.

## Definition of "qualifying year"

**2.** In the definition of "qualifying year" in regulation 2 of the Rates (Small Business Hereditament Relief) Regulations (Northern Ireland) 2010(c) for the words "1st April 2020" there shall be substituted the words "1st April 2021".
