# The Health Protection (Coronavirus, International Travel) (Amendment) Regulations (Northern Ireland) 2021

Made - - - - 22nd April 2021

Coming into operation - at 4.00 a.m. on 23rd April 2021

The Department of Health(a) makes the following Regulations in exercise of the powers conferred by sections 25B and 25F(2) of the Public Health Act (Northern Ireland) 1967(b).

#### Citation, commencement and interpretation

- 1.—(1) These Regulations may be cited as the Health Protection (Coronavirus, International Travel) (Amendment) Regulations (Northern Ireland) 2021 and shall come into operation 4.00 a.m. on 23rd April 2021.
- (2) In these Regulations, "the principal Regulations" means the Health Protection (Coronavirus, International Travel) Regulations (Northern Ireland) 2021(c).

# Amendment of the Health Protection (Coronavirus, International Travel) Regulations (Northern Ireland) 2021

**2.** The principal Regulations are amended in accordance with regulation 3.

## **Amendments to Schedule 1**

**3.** In Schedule 1 (Red list countries), at the appropriate place in alphabetical order, insert "India".

- **4.** The following Regulations are revoked—
  - (a) The Health Protection (Coronavirus, International Travel) (Amendment No. 11) Regulations (Northern Ireland) 2021(d);
  - (b) The Health Protection (Coronavirus, International Travel, Operator Liability and Public Health Advice) (Amendment) Regulations (Northern Ireland) 2021(e).
