**The Health Protection (Coronavirus, International Travel)
(Amendment) Regulations (Northern Ireland) 2021**

Made - - - - *22nd April 2021*

Coming into operation - *at 4.00 a.m. on 23rd April 2021*

The Department of Health^(a) makes the following Regulations in exercise of the powers conferred by sections 25B and 25F(2) of the Public Health Act (Northern Ireland) 1967^(b).

Citation, commencement and interpretation

1.—(1) These Regulations may be cited as the Health Protection (Coronavirus, International Travel) (Amendment) Regulations (Northern Ireland) 2021 and shall come into operation 4.00 a.m. on 23rd April 2021.

(2) In these Regulations, “the principal Regulations” means the Health Protection (Coronavirus, International Travel) Regulations (Northern Ireland) 2021^(c).

Amendment of the Health Protection (Coronavirus, International Travel) Regulations (Northern Ireland) 2021

2. The principal Regulations are amended in accordance with regulation 3.

Amendments to Schedule 1

3. In Schedule 1 (Red list countries), at the appropriate place in alphabetical order, insert “India”.

Revocations

4. The following Regulations are revoked—

- (a) The Health Protection (Coronavirus, International Travel) (Amendment No. 11) Regulations (Northern Ireland) 2021^(d);
- (b) The Health Protection (Coronavirus, International Travel, Operator Liability and Public Health Advice) (Amendment) Regulations (Northern Ireland) 2021^(e).
