The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of the Roads (Northern Ireland) Order $1993(\mathbf{b})$ and now vested in it(**c**).

The Department in accordance with Article 68(4) of that Order proposes on the completion of works providing alternative facilities for road traffic, to abandon the area of road described in the Schedule.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

Citation, commencement and interpretation

1.—(1) This Order may be cited as The Ballyboley Road, Larne (Abandonment) Order (Northern Ireland) 2021 and shall come into operation on 21st April 2021.

(2) In this Order "the Developer" means Nuport Developments Limited whose registered office is situated at 46 Hill Street, Belfast, BT1 2LB.

Application

2. The Developer shall carry out such works as the Department considers necessary for the provision of alternative facilities for road traffic and on the completion of the works the area of road described in the Schedule shall be abandoned.

3.—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned area of road shall be relocated.

(2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be extinguished.
