The Parking and Waiting Restrictions (Carrickfergus) (Amendment) Order (Northern Ireland) 2021

Made - - - - 25th March 2021

Coming into operation - 19th April 2021

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Parking and Waiting Restrictions (Carrickfergus) (Amendment) Order (Northern Ireland) 2021 and shall come into operation on 19th April 2021.

Amendment

- **2.** The Parking and Waiting Restrictions (Carrickfergus) Order (Northern Ireland) 2016(**d**) is amended by the addition to Part 2 of Schedule 2 of the following items—
 - "7. Meadowbank Road (north-west side) from a point 303 metres south-west of its junction with Sloefield Road for a distance of 16 metres in a south-westerly direction.
 - 8. Meadowbank Road (north-west side) from a point 332 metres south-west of its junction with Sloefield Road for a distance of 16 metres in a south-westerly direction.
 - 9. Meadowbank Road (south-east side) from a point 220 metres south-west of its junction with Sloefield Road for a distance of 19 metres in a south-westerly direction.
 - 10. Meadowbank Road (south-east side) from a point 250 metres south-west of its junction with Sloefield Road for a distance of 29 metres in a south-westerly direction.
 - 11. Meadowbank Road (south-east side) from a point 290 metres south-west of its

- junction with Sloefield Road for a distance of 33 metres in a south-westerly direction.
- 12. Meadowbank Road (south-east side) from a point 332 metres south-west of its junction with Sloefield Road for a distance of 20 metres in a south-westerly direction.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking and Waiting Restrictions (Carrickfergus) Order (Northern Ireland) 2016 ("the Order") by the addition of a no waiting at any time (loading and unloading not permitted) restriction on the lengths of Meadowbank Road specified in Article 2.

Vehicles are excepted from the restriction in certain circumstances.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and the Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
