Close contact services

1. “Close contact service” means—
  - (a) hairdressing or barbering;
  - (b) provision of beauty or aesthetics treatments including treatments in relation to nails or makeup;
  - (c) tattooing;
  - (d) tanning;
  - (e) services in spas;
  - (f) sports and massage therapy;
  - (g) well-being and holistic therapies;
  - (h) dress fitting, tailoring and fashion design <sup>F3</sup>...;
  - (i) body piercing;
  - (j) electrolysis;
  - (k) training in any of the services listed at (a) to (j) <sup>F3</sup>...;
  - (l) driving instruction for the test of competence to drive a vehicle other than a motorcycle established by Article 5 of the Road Traffic (Northern Ireland) Order 1981 <sup>M1</sup>.

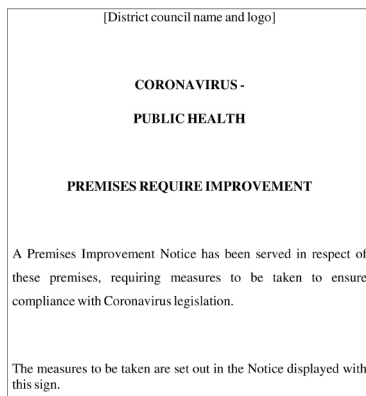
