Requirement to book and undertake tests (mandatory testing after arrival in Northern Ireland)

“public provider” means a test provider who provides or administers a test under the National Health Service Act 2006, the National Health Service (Wales) Act 2006, the National Health Service (Scotland) Act 1978 or the Health and Personal Social Services (Northern Ireland) Order 1972

“relevant isolation provisions” means—

(a) in relation to [^{F6}an eligible non-red] list arrival, regulations 10 to 13 [^{F7}, but as if the person was a non-eligible non-red list arrival]^{F8} ...,

(b) in relation to [^{F9}a non-eligible non-red] list arrival, regulations 10 to 13

(c) in relation to a red list arrival, regulation 14 and Schedule 7

[^{F11}(1A) For the purposes of this Schedule, —

(a) a LFD test is a test which satisfies the requirements of paragraph 7A(2) of Schedule 8 to the Health Protection (Coronavirus, International Travel and Operator Liability) (England) Regulations 2021 (general requirements for lateral flow tests),

(b) a PCR test is a test which satisfies the requirements of paragraph 6(2) of Schedule 8 to the Health Protection (Coronavirus, International Travel and Operator Liability) (England) Regulations 2021 (general requirements for polymerase chain reaction tests).]

(2) Where this Schedule requires P to enter into or continue to isolate in accordance with the relevant isolation provisions Part 4 applies in relation to that requirement as it applies in relation to the relevant isolation provisions.

- (a) red list arrivals,
 - (b) ^{F13}non-eligible non-red] list arrivals.

(3) Where the mandatory test has generated an inconclusive result, P may undertake a confirmatory PCR test.

- (a) paragraph 5(2) (in a case where the original result was positive),

Required circumstances for undertaking a day 2 test or a day 8 test

- 8.—(1) The circumstances mentioned in regulation 8(11) are as follows.
- (2) In relation to—
 - (a) a day 2 test, P undertakes the test [^{F35}in accordance with the manufacturer’s instructions for use] no later than the end of the second day after the day on which P arrived in Northern Ireland ^{F36} ...,
 - (b) a day 8 test, P undertakes the test [^{F37}in accordance with the manufacturer’s instructions for use] no earlier than the end of the seventh day after the day on which P arrived in Northern Ireland.

[^{F38}(3) Subject to [^{F39}sub-paragraph (4)], at the time the test is booked P provides the test provider with the following information—

- (a) notification that P is to undertake the test under these Regulations;
- (b) the information set out in sub-paragraph (6), and
- (c) P’s home address and where P is—
