The Licensing (Notice Relating to Local Producer's Premises – Authorisation for On-Sales) Regulations (Northern Ireland) 2022

Made - - - - 23rd March 2022

Coming into operation - 2nd June 2022

The Department for Communities(a) makes the following Regulations in exercise of the powers conferred on it by Article 52F(9) of the Licensing (Northern Ireland) Order 1996(b) and now vested in it(c).

### Citation and commencement

**1.** These Regulations may be cited as the Licensing (Notice Relating to Local Producer's Premises – Authorisation for On-Sales) Regulations (Northern Ireland) 2022 and shall come into operation on 2nd June 2022.

#### Form and dimensions of Notice

- 2. A notice under Article 52F(9) of the Licensing (Northern Ireland) Order 1996 must
  - (a) contain the information specified in the Schedule; and
  - (b) be contained in a document the dimensions of which are no less than 297 mm in length and 210 mm in width.

## **SCHEDULE**

Regulation 2

# Notice relating to local producer's premises – authorisation for onsales

It is an offence for the holder of a local producer's licence, personally or by a servant or agent, to sell, or make available for purchase, intoxicating liquor produced in the production premises for consumption in this part of the premises unless:

- (a) a suitability order under Article 52E of the Licensing (Northern Ireland) Order 1996 has been granted for this part of the premises;
- (b) an authorisation under Article 52F of that Order has been granted and is in force;
- (c) the sale of intoxicating liquor is during the permitted hours, being from 4 in the afternoon to 10 in the evening; and
- (d) the consumption or permitted consumption of intoxicating liquor outside permitted hours is during the first 60 minutes after the conclusion of the permitted hours.

### **EXPLANATORY NOTE**

(This note is not part of the Regulations)

These Regulations prescribe the form and dimensions of the notice, and contain information relating to the sale and consumption of intoxicating liquor, that local producers of intoxicating liquor must display in the part of their premises granted a suitability order under Article 52E of the Licensing (Northern Ireland) Order 1996, when authorised to sell for consumption in that part of their premises under Article 52F of that Order.
