**The Parking and Waiting Restrictions (Lisburn) (Amendment)
Order (Northern Ireland) 2022**

Made - - - - - *27th October 2022*

Coming into operation - *18th November 2022*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as the Parking and Waiting Restrictions (Lisburn) (Amendment) Order (Northern Ireland) 2022 and shall come into operation on 18th November 2022.

Amendment

2. The Parking and Waiting Restrictions (Lisburn) Order (Northern Ireland) 2021^(d) is amended by the addition to Part 1 of Schedule 2 of the following items—

- “32. Warren Park (north side) – from a point 15 metres west of its junction with Hillsborough Road for a distance of 345 metres in a westerly direction.
- 33. Warren Park (south side) – from a point 15 metres west of its junction with Hillsborough Road for a distance of 297 metres in a westerly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Parking and Waiting Restrictions (Lisburn) Order (Northern Ireland) 2021 (“the Order”) by the addition of a no waiting at any time (loading and unloading permitted) restriction on lengths of Warren Park, Lisburn as specified in Article 2.

Vehicles are excepted from the restriction in certain circumstances.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and the Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
