The State Pension Debits and Credits (Revaluation) Order (Northern Ireland) 2022

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the State Pension Debits and Credits (Revaluation) Order (Northern Ireland) 2022 and shall come into operation on—
 - (a) 21st December 2022 for the purpose of making an award on a claim for a state pension under regulation 15(1) of the Social Security (Claims and Payments) Regulations (Northern Ireland) 1987(1) (advance notice of retirement and claim for and award of pension) to a person who reaches pensionable age(2) on or after 11th April 2023; and
 - (b) 10th April 2023 for all other purposes.
- (2) In this Article "a state pension" means a state pension under Part 1 of the Pensions Act (Northern Ireland) 2015(3).

The increase in the amount of relevant debits or credits

2. For the purposes of paragraph 3 of each of Schedules 8 and 10 to the Pensions Act (Northern Ireland) 2015 (pension sharing: appropriate weekly rate and reduction), the amount of relevant debits or credits for the tax year specified in the first column of the table set out in the Schedule to this Order is directed to be increased by the percentage of their amount specified in the corresponding entry in the second column.
