**The Road Traffic (Fixed Penalty)  
(Amendment) Order (Northern Ireland) 2023**

*Made* - - - - *20th April 2023*  
*Coming into operation* *15th May 2023*

The Department for Infrastructure<sup>(1)</sup> makes the following Order in exercise of the powers conferred by Article 59(1) of the Road Traffic Offenders (Northern Ireland) Order 1996<sup>(2)</sup> and now vested in it<sup>(3)</sup>.

In accordance with Article 91(1) of that Order the Department has consulted with such representative organisations as it thinks fit.

**Citation and commencement**

1. This Order may be cited as the Road Traffic (Fixed Penalty) (Amendment) Order (Northern Ireland) 2023 and shall come into operation on 15th May 2023.

**Amendment of the Road Traffic (Fixed Penalty) Order**

2. In Schedule 1 to the Road Traffic (Fixed Penalty) Order (Northern Ireland) 2007<sup>(4)</sup> (fixed penalties), after item 25 insert—

“25A.	A fixed penalty offence under Article 12 of the Road Traffic (Northern Ireland) Order 1995	£100”.

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order amends Schedule 1 to the Road Traffic (Fixed Penalty) Order (Northern Ireland) 2007 by inserting an amount of £100 for the fixed penalty prescribed for the offence under Article 12 of the Road Traffic (Northern Ireland) Order 1995.

The new fixed penalty relates to the offence of driving a mechanically propelled vehicle on a road or other public place without due care and attention, or without reasonable consideration for other persons using the road or place.
