EXPLANATORY MEMORANDUM TO

The Alleyway to the rear of Nos. 92-122 Royal Avenue, Belfast (Abandonment) Order (Northern Ireland) 2024

S. R. 2024 No. 105

1. Introduction

- 1.1. This Explanatory Memorandum has been prepared by the Department for Infrastructure to accompany the Statutory Rule (details above) which is laid before the Northern Ireland Assembly.
- 1.2. The Statutory Rule is made under Article 68(1) and (5) of The Roads (Northern Ireland) Order 1993 and is subject to the negative resolution procedure.

2. Purpose

- 2.1. The purpose of the rule is to abandon an area of 101.47 square metres of former alleyway to the rear of nos. 92-122 Royal Avenue, Belfast, extending from its junction with Kent Street for a distance of 36.37 metres in a south-westerly direction.
- 2.2. The area of alleyway in question will be abandoned as the Department is of the opinion that it is no longer necessary.
- 2.3. On the coming into operation of the rule, the area of road in question shall cease to be maintainable by the Department and the public right of way over it shall be extinguished.

3. Background

- 3.1. The abandonment has been requested by Belfast City Council, who are the owners of the bed and soil of the area to be abandoned, to facilitate the redevelopement of the wider site which will provide a new tourist destination in connection with the Belfast Stories Project. The redeveloped site will also include a cinema and centre for Northern Ireland Screen Industries and social spaces.
- 3.2. Following the abandonment the land will revert to the owners of the bed and soil so that redevopment of the area can proceed.

4. Consultation

- 4.1. The PSNI has been consulted and has no objection. Belfast City Council has also been advised of the proposed abandonment.
- 4.2. In accordance with the statutory consultation process a notice in respect of the proposed abandonment was published in the local press for two successive weeks. In addition, a notice was posted on site and the statutory undertakers were notified of the proposal. Following the advertisement of the notice in the local press, no objections were received.

5. Equality Impact

5.1. Consideration has been given to compliance with Section 75 of the Northern Ireland Act 1998. No equality issues have been identified by the

Department and no issues were raised following the publication of the notice in the press.

6. Regulatory Impact

6.1. A Regulatory Impact Assessment was not considered necessary as the proposal does not result in any costs or savings to business, charities or the voluntary bodies.

7. Financial Implications

7.1. The applicant has signed an undertaking to reimburse the Department's costs and expenses and to pay any compensation due as a result of making the Rule.
