The Department of Finance(1) makes the following Order in exercise of the powers conferred by Article 39A(1) of the Rates (Northern Ireland) Order 1977(2)

#### **Citation and commencement**

**1.** This Order may be cited as the New NAV List (Time of Valuation) Order (Northern Ireland) 2024 and shall come into operation on 31st January 2024.

#### **Specification of time**

**2.** 1st April 2024 is the time by reference to which a net annual value to be ascribed to any hereditament in a new NAV list coming into force on 1st April 2026 is to be ascertained.
