The Department of Agriculture, Environment and Rural Affairs( $\mathbf{a}$ ) makes these Regulations in exercise of the powers conferred by sections 5 and 6 of the Agriculture Act (Northern Ireland) 1949( $\mathbf{b}$ ).

These Regulations are made with the approval of the Department of Finance(c) under sections 5 and 6 of the Agriculture Act (Northern Ireland) 1949.

#### Citation and commencement

**1.** These Regulations may be cited as the Farming for the Generations Scheme (Amendment) Regulations (Northern Ireland) 2024 and shall come into operation on 6th March 2024.

# Amendment to the Farming for the Generations Scheme Regulations (Northern Ireland) 2024

**2.**—(1) The Farming for the Generations Scheme Regulations (Northern Ireland) 2024(**d**) are amended as follows.

(2) Omit regulation 9.

(3) In regulation 11, omit paragraph (1)(c).
