**The Farming for the Generations Scheme (Amendment)
Regulations (Northern Ireland) 2024**

Made - - - - *6th March 2024*

Coming into operation *6th March 2024*

The Department of Agriculture, Environment and Rural Affairs(a) makes these Regulations in exercise of the powers conferred by sections 5 and 6 of the Agriculture Act (Northern Ireland) 1949(b).

These Regulations are made with the approval of the Department of Finance(c) under sections 5 and 6 of the Agriculture Act (Northern Ireland) 1949.

Citation and commencement

1. These Regulations may be cited as the Farming for the Generations Scheme (Amendment) Regulations (Northern Ireland) 2024 and shall come into operation on 6th March 2024.

Amendment to the Farming for the Generations Scheme Regulations (Northern Ireland) 2024

2.—(1) The Farming for the Generations Scheme Regulations (Northern Ireland) 2024(d) are amended as follows.

- (2) Omit regulation 9.
- (3) In regulation 11, omit paragraph (1)(c).

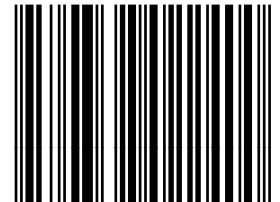
